Changes to this contract will void the original contract requiring a new contract to be signed by the volunteer upon review and acceptance of the new contract terms.

By submitting this document you agree that:

- (1) You are honest and trustworthy
- (2) You are 21 years of age or older *
- (3) You have no criminal background record
- (4) You have no history of mental illness
- (5) You are not being treated for depression, schizophrenia, personality disorders, hallucinations, alcoholism, drug addictions or any other condition that may potentially endanger yourself, another team member or client
- (6) You have a job and/or steady source of income
- (7) You are not on any medication that may cause hallucinations or impair your judgement
- (8) You agree that the use of dark energy, invocations, spells or any other form of black magic is strictly prohibited by ASP and agree not to use any of these
- (9) Failure to disclose any of the above may result in the termination for ASP and the volunteer will be obligated for all fees and court costs resulting in a lawsuit for breach of contract
